EXCLUSIVE CONTRACT BETWEEN ARTIST AND TALENT AGENCY

- I hereby employ you as my exclusive talent agency for a period of ____ years (not to exceed 7 years) from
 date hereof to negotiate contracts for the rendition of my professional services as an artist, or otherwise, in
 the fields of motion pictures, legitimate stage, radio broadcasting, television and other fields of
 entertainment.
- I hereby agree that you may advise, counsel or direct me in the development and/or advancement of my professional career.
- As compensation for your said services agreed to be rendered hereunder, I hereby agree to pay you a sum percent (____%); not to exceed maximum rate shown on fee schedule of all monies or things of value as and when received by me directly or indirectly, as compensation for my professional services rendered or agreed to be rendered during the term hereof under contracts, or any extensions, renewals, modifications, or substitutions thereof, entered into or negotiated during the term hereof and to pay the same to you thereafter for so long as you remain licensed. It is expressly understood that to be entitled to continue to receive the payment compensation on the aforementioned contracts, after the termination of this agreement, you shall remain obligated to serve me and perform obligations with respect to said employment contracts or to extensions or renewals of said contracts or to any employment requiring my services on which such compensation is based. Once you are booked on a job with Made Worldwide Agency, Inc. we'll have a payment ready for you shortly after. Most jobs require you to complete an easy recap form as soon as the job is complete. We'll then forward that information along with any photos you took while on the job to the client. Then we send the clients an invoice from there. Please note we cannot send them an invoice for a job until we know how it all went. The sooner you submit this report the sooner you will be paid. Once we receive the check from the client for that invoice and it clears the bank, it goes directly into our next payroll. Please keep in mind that most clients have a net 30 payment period. And that our payroll goes out as soon as the payments are ready. Once we have your direct deposit information, we will add it to Venmo, Cash App or TD Bank online bill pay system if you prefer checks. You will then be able to view your payment memos on our date base, My Agency Pal under invoices, so you know exactly what that payment is for in the case that you may be expecting several. Since we send the payments out as we get them in. Meaning if you have booked several times with us but only see a payment for one of the bookings then most likely the rest will be in the next payroll once we receive those funds. If you earn more than \$600 a year with us, you will receive a 1099 from our accountant at the end of the year. Please make sure we always you're your most up to date address on your W9 on file to receive those in a timely matter. Please not 20% is the maximum commission percentage that will be charged towards our Artist(s). This percentage cannot exceed 20%
- 4. I hereby agree that you may render your services to others during the term hereof.
- 5. In the event that I do not obtain a bona-fide offer of employment from a responsible employer during a period of time in excess of four (4) consecutive months, during which said time I shall be ready, able, willing, and available to accept employment, either party hereto shall have the right to terminate this contract by notice in writing to that effect sent to the other by registered or certified mail.
- 6. Controversies arising between us under the provisions of the California Labor Code relating to talent agencies and under the rules and regulations for the enforcement thereof shall be referred to the Labor Commissioner of the State of California as provided in Section 1700.44 of the California Labor Code.
- 7. In the event that you shall collect from me a fee or expenses for obtaining employment for me, and shall fail to procure such employment, or shall fail to be paid for such employment, you shall, upon demand, therefore, repay to me the fee and expenses so collected. Unless repayment thereof is made within forty-eight (48) hours after demand therefore, you shall pay to me an additional sum equal to the amount of the fee as provided in Section 1700.40 of the California Labor Code.
- 8. Subject to my availability, you hereby agree to use all reasonable efforts to procure employment for me in the field or fields of endeavor specified in the contract in which you represent me.
- 9. This instrument constitutes the entire agreement between us. Statements, promises, or inducements made by any party hereto that are not contained herein shall not be binding or valid, and this contract may not be enlarged, modified, or altered, except in writing signed by both the parties hereto; and provided further, any substantial changes in this contract must be approved by the Labor Commissioner.
- 10. You here by agree to deliver to me an executed copy of this contract.
